The AI (Artificial Intelligence) module is an extension for PIXMO. The AI tool visualizes all flooring products in the customer's own room photos. The AI tool automatically recognizes the floor surfaces and prepares them for the product configuration and visualization. Customers can immediately see what the product looks like in their own room.

## General terms and conditions and explanations

- (1) The PIXMO Room Studio is an SaaS (Software as a Service) solution and hosted by VEEUZE on a central server cluster.
- (2) With this order, you are concluding a hosting service agreement that includes all hardware and services required for the smooth usage on the internet as well as constant software and content maintenance. For the term of this agreement, VEEUZE ensures unlimited access to the PIXMO Room Studio. The hosting service package includes a 99.5% availability per month.
- (3) The hosting service package includes the following detailed services:
  - a. Continuous server-side administration of your retailer version
  - b. Unlimited data transfer
  - c. Provision of sufficient server capacities
  - d. Continuous integration of the updated product catalogs
  - e. Continuous adjustment of the software to browser updates
- (4) The functional scope of the Select Basic, Pro and Pro+ versions is identical.
- (5) With regard to product data maintenance, the three versions differ as follows:
  - a. Select Basic  
All users receive an EXCEL list containing all available manufacturer/ brand names. From this list, they can choose which brands they do not wish to present in the application. As soon as a new product line by a new supplier becomes available, they will be informed of this fact via email and asked whether they wish to incorporate this supplier in his individual product range.
  - b. Select Pro  
In principle, the same procedure applies to Select Pro as to the Select Basic version. However, the product lines can be subdivided into series. Users additionally have the option of displaying or hiding individual series by the suppliers.
  - c. Select Pro+  
With the Select Pro+ version, all users have the option to individualize the product lines for each item. They can enter their individual item numbers and/or product names into the product list without the brand/series name of the individual supplier being visible.
- (6) Each user independently configures or designs his own product range. VEEUZES assumes no liability for the correctness of product data represented in the PIXMO Room Studio. Any derived liability claims are excluded.
- (7) When it comes to product catalog maintenance, we depend on the collaboration with the manufacturers who are represented in PIXMO Room Studio with their product catalogs. Please note that there may be delays in product catalog updates, some of which lie outside the area of responsibility of VEEUZE.
- (8) The parties agree upon a minimum usage term of 12 months.
- (9) After the minimum usage term has expired, the contract can be terminated through ordinary termination in writing three months before the end of the contractual year in question. If this deadline is exceeded, the contractual term automatically extends by another 12 months. After the contract is terminated, the SaaS solution PIXMO Room Studio can no longer be used.

- (10) Ownership and usage rights for all product data/photos used in PIXMO Room Studio remain with the supplier in question. The user is granted the right for using the suppliers' product data exclusively in PIXMO Room Studio. Based on this agreement, any release to a third party or usage in other programs or media is excluded.
- (11) The AI module for PIXMO is an AI-controlled photo service from VEEUZE.
- (12) By ordering a monthly upload package, you enter into a service contract for a quota of photo uploads. If the monthly upload quota is exceeded in two consecutive months, you will receive a message in the following month that an upgrade to the next higher upload package will take place. For room photos that exceed the booked upload package in the relevant months, an additional fee of € 0.10 per room photo will be charged. Unused quotas expire at the end of the billing month.
- (13) A minimum period of use of 12 months is agreed for the AI tool. During the contract period, the upload quota can be upgraded or downgraded with one month's notice.
- (14) In order to use the AI tool in accordance with the General Data Protection Regulation (GDPR), each customer receives a text addendum when handing over the link to the AI tool, which they should integrate into their privacy policy.
- (15) After expiry of the minimum period of use, the contract may be terminated by either contracting party ordinarily in writing with a notice period of 3 months before the end of the respective contract year. If the notice period is exceeded, the contract period shall be automatically extended by a further 12 months. With the termination of the contract, the AI module for PIXMO can no longer be used.
- (16) With the cancellation of the PIXMO Room Studio contract, the AI module for PIXMO is automatically terminated.
